VA adopts Login.gov for a unified Veteran sign-in experience

The government-based service provides seamless experiences across multiple

government platforms

WASHINGTON — By creating an account on Login.gov, Veterans can now use the same login and password to access a growing list of federal government websites, including the Department of Veterans Affairs, Office of Personnel Management and Small Business Administration to deliver a secure and streamlined identity verification experience.

<u>Currently, Veterans can login to VA.gov, My HealtheVet and VA's flagship Health and Benefits mobile app using Login.gov.</u>

One account and password

Login.gov is a secure sign-in service used by the public to sign in to participating government agencies. Participating agencies will ask you to create a Login.gov account to securely access your information on their website or application.

You can use the same username and password to access any agency that partners with Login.gov. This streamlines your process and eliminates the need to remember multiple usernames and passwords.

What to expect

A committee may consider several bills during an afternoon. The committee chairperson will announce the order in which bills will be heard, the rules for testifying and whether there will be a time limit on your testimony.

The length of time spent on each bill varies, depending largely on the number of people testifying, the length of their testimony and the number of questions asked by committee members.

Each bill first will be presented by the senator who sponsors it. Committee members may follow up with questions. The committee chairperson then will ask proponents of the bill to testify. Then opponents of the bill will be invited to testify, followed by those giving neutral testimony.


Addressing committee members or testifiers from the audience is prohibited. Applause and other public demonstrations also are prohibited. Please turn off phones to avoid disturbing the hearing.

Senators routinely come and go during hearings. They have other commitments, including the presentation of bills in other committees that are meeting simultaneously.

Testifier Tips







ABOUT COMMITTEES

Bills introduced in the Legislature must receive a public hearing by a legislative committee. These hearings are an opportunity for citizens to speak directly to state senators regarding the creation of Nebraska laws. Everyone is allowed to testify at public hearings and all testimony is included in the official committee record.

The Nebraska Legislature has 14 standing committees: • Agriculture • Appropriations • Banking, Commerce and Insurance • Business and Labor • Education • General Affairs • Government, Military and Veterans Affairs • Health and Human Services • Judiciary • Natural Resources • Nebraska Retirement Systems • Revenue • Transportation and Telecommunications • Urban Affairs Each of these committees has six to nine members.

HEARING LOCATIONS AND TIMES

Public hearings on bills typically are held in the afternoons during the first half of the legislative session. Committees have regularly scheduled rooms and meeting days, although they sometimes meet in different rooms at varying times in order to accommodate testifiers or large audiences.

Hearings usually begin at 1:30 p.m. See the hearing room assignments and a Capitol map on the back of this brochure. The weekly schedule of committee hearings is published on the last legislative day of the week throughout the legislative session.

The schedule is available on a table in front of the Clerk's Office, in the Sunday editions of the Lincoln Journal Star and the Omaha World-Herald, in the weekly Unicameral Update (update. legislature.ne.gov) and at NebraskaLegislature.gov.

If auxiliary aids or reasonable accommodations are needed for you to attend a hearing, please call the Office of the Clerk of the Legislature at 402-471-2271. If you have a hearing or speech impairment, please call the Nebraska Relay System at 800-833-7352 (TTY) or 800-833-0920 (Voice). Advance notice of 10 business days is needed when requesting an interpreter.

PUBLIC TESTIMONY

If you plan to provide copies of your testimony, please consider contacting the committee to see if they prefer electronic submissions. If providing hard copies, please bring enough for each committee member, plus three more for support staff.

Please fill out the sheet provided in the hearing room prior to testifying. Once you are seated at the testifier's table, you must identify yourself, spell your name, and state what organization you represent, if any. Speak directly into the microphone, as committee proceedings are transcribed.

Be prepared to limit your testimony to three to five minutes. If you also are providing written testimony, please summarize rather than read it verbatim.

Committee members may ask questions after your testimony. However, testifiers are not allowed to ask questions of committee members.

If you are not testifying on a bill in person and would like to submit written comments online to be included in the official hearing record as an exhibit, you may do so on the corresponding bill page at NebraskaLegislature.gov. To be included in the official hearing record, online comments must be submitted by 12 p.m. CST on the last workday immediately preceding a bill's public hearing.

Nicole: I'd like to mention that currently there are transcripts available for legislative proceedings, but those transcripts are not always available in a timely manner. When you are able to locate them, you have to go through dozens, sometimes hundreds of pages, just to find information on maybe that one bill that you're looking for. And some people may like to read, some people prefer to obtain their information through a presentation. So, being able to watch a video would fit their needs better. As a legislator, in a single session, you might be dealing with and weeding through 600 – 700 introduced bills. As a senator, you can't know everything that's going on in every committee.

Workforce Licensing Recognition

Breaking Down Barriers to Work

Problems

Laura Ebke, Senior Fellow at The Platte Institute and former Nebraska State Senator shares her perspective on workforce licensing recognition

- · Nebraska is faced with a workforce shortage.
- In Nebraska, nearly 1-4 jobs require some sort of government permit or license
- Approximately 200 occupations in Nebraska require some form of state licensure
- Many of Nebraska's initial job licensing requirements are burdensome compared to other states.
- Workers and families whose jobs require state licensing look at the difficulty of meeting licensing requirements.

The Solution

Recognition of Workforce Experience

- Recognizes workers don't lose their skills because they cross state lines.
- Licensing boards accept licenses from other states with similar scopes of practice.
- Focus on the experience, rather than widely diverse initial licensing requirements across the country.
- Provides full recognition of virtually all occupations including for military spouses and family.
- Recognizes military occupational specialty (MOS) for those who have trained in civilian licensed occupations
 during their service.

<u>Overview</u>

- Many states moved to waive licensing requirements for out-of-state healthcare workers at the onset of the
- COVID-19 pandemic, allowing healthcare professionals to move easily across state lines.

- If recognition of other-state licensure was safe in fields that directly impacted ng public health and safety, we should broaden its scope to include other occupations for workforce development
 - Nineteen states have passed some form of broad universal recognition at least seven had introduced broad legislation in the 2021-2022 legislative sessions, a few have broadly recognized occupations of veterans and military spouses.u= recognizes workers don't lose their skills because they cross state lines.

Nebraska's First Casino

Nebraska's first casino has already sent nearly \$800,000 to property tax relief Tax revenue realized after first five weeks of operation of WarHorse casino in Lincoln By: Paul Hammel - November 14, 2022 8:07 pm

LINCOLN — Nebraska's first gambling casino has contributed nearly \$800,000 to a state property tax relief fund so far, including \$597,854 during the month of October, a state report indicated Monday.

And officials with the WarHorse Casino expect that gaming tax revenues will steadily grow as they begin advertising and marketing the temporary facility at the Lincoln Race Course on the southwest edge of Lincoln.

"We're really pleased at the way it's been received," said Lynne McNally, the CEO of the state's horsemen's association. "It was very important to us to start contributing to that property tax relief fund."

70% to property tax relief

Casinos are required to pay 20% of their gross gambling revenue in state gaming taxes, with 70% of that money going to the state's long-running Property Tax Credit Fund. That fund reduces a portion of local property tax bills. Another 25% of gaming taxes are split evenly between the host county and host city for a casino.

Thousands of independent pharmacies now able to rejoin Tricare network

Nearly <u>15,000 independent pharmacies</u> will have a chance to rejoin the Tricare retail pharmacy network, according to officials with Express Scripts.

The move comes in response to the Kroger grocery chain's Sept. 30 announcement that its 2,200 pharmacies in 35 states would no longer participate in the Tricare provider network, officials said.

Express Scripts will send a notice announcing a December contract solicitation directly to the pharmacies that either declined the recent contract or are affiliated with a wholesaler that declined the contract on their behalf. If the pharmacy

accepts the contract, it will be able to rejoin the Tricare network effective Jan. 15.

Dear Dean,

Thank you for contacting me about pharmacy benefits under TRICARE. I appreciate you sharing your concerns with me, and I agree with you.

As you know, in recent weeks, Express Scripts, which manages the pharmacy benefit for TRICARE beneficiaries, announced their new contracts for 2023. According to reports, these contracts will lower reimbursements to many community pharmacies and likely result in many leaving the program.

I share your concern about the impact of these new contracts and the potential for TRICARE beneficiaries to lose access to this important benefit. I am particularly concerned about the consequences for TRICARE beneficiaries in rural areas as these areas often only have community pharmacies.

That is why I joined several of my Senate colleagues in sending a <u>letter</u> to the Department of Defense's Health Agency, requesting answers to a series of questions about what steps they are taking to monitor current and future TRICARE pharmacy contracts, as well as what steps they are taking to ensure adequate access to in-person pharmacy services for TRICARE beneficiaries.

It is critical to ensure that TRICARE beneficiaries have access to this important benefit. Please be assured that I will continue to closely monitor this issue in the days and weeks ahead.

Governor's and Mayor's Challenges to Prevent Suicide Among Service Members, Veterans, and their Families

SAMHSA has partnered with the United States Department of Veterans Affairs (VA) to bring the Governor's and Mayor's Challenges to Prevent Suicide Among Service Members, Veterans, and their Families (SMVF) to states, territories, and communities across the Nation. For the Governor's Challenge, 52 states and territories are taking part in the challenge and are working to develop and implement state-wide suicide prevention best practices for SMVF, using a public health approach. For the Mayor's Challenge, 22 communities were originally engaged as part of the challenge. Currently, 19 of those teams are still actively participating, and sixteen of the communities are within participating Governor's Challenge states. SAMHSA's SMVF TA Center is providing technical assistance for these initiatives.

From Daryl Harrison

Governor's Challenge is a combined effort of the Veterans Administration and the Substance Abuse and Mental Health Administration to reduce Veteran Suicide.

This is a three-pronged attack. Later I will share my reasoning for labeling it an attack. The three prongs are:

- 1. Identify Service Members, Veterans, and their Families and screen for Suicide Risk
- 2. Promote Connectedness and Improve Care Transitions
- 3. Increase Lethal Means Safety and Safety Planning.

Governor's Challenge group 2 was formed by the Nebraska Department of Veterans Affairs and Nebraska Department of Health and Human Services and is charged with developing the protocols, procedures, and interagency relationships that will prevent veteran suicide in Nebraska.

In my many years, I have never participated in a working group of such intellectual and experiential depth and breadth. It will be called upon. In the brief four months, we have been formed, the following studies have come out.

The first has an Issue Date of 10/20/2022

Comprehensive Healthcare Inspection Summary Report FOUND:

The OIG identified a weakness with the completion of mandatory training by staff who develop suicide safety plans. Lack of training could prevent staff from providing optimal treatment to veterans who are at risk for suicide.

The OIG subsequently issued one recommendation.

It READS:

The Under Secretary for Health, in conjunction with Veterans Integrated Service Network directors and facility senior leaders, ensures that staff complete mandatory suicide safety plan training prior to developing suicide safety plans.

As you likely know Commissioners, if the core of educational delivery is lacking, the direct consequence of poorly informed or uninformed staff causes synergistic dilution of success. In this case, I know that means our brothers and sisters are paying for this shortcoming in their lives.

Now, let me share with you why this must be an attack on SMVF suicide.

A report of America's Warrior Partnership dated 9/17/2022 tells us:

When suicide and SIM (Self Injury Mortality) rates "are combined, this brings the true rate of deaths among former service members to at least 44 per day or 2.4 times the rate the VA reports."

I do not wish to undermine the VA or bolster the positions of sidebar studies yet we must act swiftly, educated, and with compassion.

• Please return to your organizations, your constituents, your friends, and your families to let them know there is a group of their fellow Nebraskans named the Governor's Challenge fighting to save Service members' and Veterans lives. Ask them to support our endeavors if called upon and pray for us as we move forward.



BELLEVUE, Neb. (WOWT) - At any given moment Nebraska has 3,500 men and women ready to problem solve. The trend has been to move National Guard readiness centers out of communities. The military here argued that this one should be in Bellevue because of the location.

It's between Offutt Air Force Base and base housing.

"It's very important for us to be a part of that because the National Guard has always been part of the fabric of a community," said Col. Brent Flachsbart with the Nebraska National Guard.

In two years this will become the 43rd readiness center in Nebraska.
