Military retirees and disabled veterans will see their monthly checks increase by 8.7% for 2023, thanks to an annual adjustment to the federal Cost of Living Allowance (COLA) due to inflation. This will be the largest increase since 1981 Retirees saw a 5.9% increase in 2022 and 1.3% in 2021; the annual adjustment has averaged 1.9% for the last 10 years.

Military Retirement Pay State Tax Breaks for Qualifying Veterans

• Note that beginning in 2022, for all veterans, 100% of military retirement pay will be exempt from Nebraska income tax. This change is due to LB 387, Legislation for Tax Relief on Military Retirement Pay signed by Gov. Ricketts on May 26, 2021.



Hi Dean,

Next week, the First Session of the 108th Nebraska Legislature will convene and twenty-six new and returning State Senators will take their oath of office. Most remarkable, we will also witness the swearing in of Nebraska's 41st Governor whom, like so many of the legislators, will have spent months listening to Nebraskans and immersing himself in the issues that are important to our families and businesses.

With so many of our leaders fresh off the campaign trail and mindful of the will of the people, this is truly an exciting

and pivotal time for our state. But the lack of institutional knowledge and experience can also be a challenge. Therefore, we thought it would be good to review a few of our basic lessons from the past:

Find Unity Among Nebraska Taxpayers

Rural and urban taxpayers have too often been at odds over tax policy priorities in the Nebraska Legislature. While we can't discount the urban-rural divide—even in tax policy—we're all Nebraskans, and working together to support a common goal of tax reform would improve all of our lots. After all, Nebraska has cut taxes in a number of valuable ways in recent years.

Without dismissing the sometimes-bitter feelings among different taxpayer groups, all could still be better off compared with their peers in other states. Taxpayers need to support each other toward that goal.

With record cash on hand and peer states continuing to make improvements, Nebraskans must collaboratively focus on meaningful solutions in 2023 and beyond.

Leverage Nebraska's Nonpartisan Structure

I can't think of a good legislative accomplishment that hasn't required some kind of cooperation across party lines, often because we learn that party affiliation doesn't truly capture lawmakers' policy priorities.

Don't worry too much about who gets the credit and keep your eyes on building a freer and more prosperous state. Tax reform, innovation and workforce solutions count on it.

Always Place Policy Ahead of Politics

When we focus too much on the personalities of officials, we begin to tune out the content of our policy debates and miss opportunities.

What I'm saying is admittedly "bad" political campaign advice, but it's good life advice for people who want to improve their states or communities between elections, which is when most of the work of government really happens.

Sometimes these "opponents" will actually be right about something. If you focus on the ideas, rather than people and personalities, you might even discover you can do a better job realizing the good idea they're putting forward.

There are so many reasons to be optimistic about what Nebraska can accomplish. But the best work will happen when our leaders act and make policy based on what Nebraskans can achieve, and our Platte Institute team is ready to be a valuable partner.

Tips on Testifying at a Committee Hearing

The Hearing Process

A committee may consider several bills during an afternoon. The committee chairperson determines the order in which bills will be heard, the rules for testifying and whether there will be a time limit on your testimony. The length of time spent on each bill varies and depends largely on the number of people testifying, the length of their testimony and the number of questions asked by committee members.

Usually, unless otherwise indicated, hearings begin at 1:30 p.m. Each bill is presented by the senator who sponsors it. After the sponsoring senator finishes his or her introduction, the committee chair typically will ask proponents of the bill to come forward individually and state their reasons for supporting the measure. Then, the chair will ask the bill's opponents to come forward and state their opinions. Often, committee chairpersons will allow individuals to testify in a neutral capacity.

If you want to testify before the committee, you will need to fill out the sign-in sheet at the witness table, orally identify yourself and spell your last name for the record, and state who, if anyone, you represent as you begin your testimony. It is important to remember that committee proceedings are transcribed verbatim.

Letters or written communications containing support, opposition or neutral testimony also are accepted by committees during a bill's public hearing. Persons wishing to send written information should address their correspondence to the office of the senator who chairs the committee and ensure that the information arrives before the hearing.

Citizen Testimony

As a concerned citizen, there are several ways in which you may communicate effectively with your senator in an attempt to suggest or influence legislation. One way is to testify at a legislative hearing.

At public hearings, citizens have an opportunity within the time available to make their views known or have them incorporated into the official committee record. In Nebraska, gubernatorial appointments and most bills, with the exception of a few technical bills, receive a public hearing by one of the Legislature's committees.

Generally, testimony on legislative bills is heard by one of the Legislature's 14 standing committees:

Agriculture

Appropriations

Banking, Commerce and Insurance

Business and Labor
Education
General Affairs
Government, Military and Veterans Affairs
Health and Human Services
Judiciary
Natural Resources
Nebraska Retirement Systems
Revenue
Transportation and Telecommunications
Urban Affairs

Each of these committees has seven to nine members.

Public hearings on bills typically are held in the afternoons during the first half of the legislative session. Committees have assigned hearing rooms and meeting days, although they sometimes meet at different times and places in order to accommodate witnesses or large audiences.

Testimony Tips

- Be aware that sometimes the sponsor of a bill will offer amendments when he or she presents the bill to the committee. These proposed amendments may change the way you feel about the bill and, thus, affect your testimony.
- Be prepared to limit your testimony and try not to repeat testimony offered by previous witnesses. Remember
 that while senators want to hear what you have to say, there are numerous witnesses who also want to be heard.
- Be prepared to answer questions asked by committee members.
- Most observers agree that, as a witness, you will be more effective in getting your message across if you have
 prepared your testimony in writing. If you do this, it is helpful to bring enough copies to distribute to all
 committee members, the two committee staff members, media and the transcribers' office. Fifteen copies is
 usually enough to accomplish this. If written testimony is lengthy, it can be distributed and summarized orally
 to conserve the committee's time.
- Addressing committee members or witnesses from the audience, public demonstrations and applause are prohibited.
- You should not be offended if senators come and go during a hearing. They have other commitments, including the presentation of bills in other committees that are meeting simultaneously.
- If auxiliary aids or reasonable accommodations are needed for you to attend a hearing, please call the Office of the Clerk of the Legislature, (402) 471-2271, or if you have a hearing or speech impairment, please call the Ombudsman's Office at (402) 471-2035 or 800-742-7690. Advance notice of seven days is needed when requesting an interpreter.

Online database:

In order to facilitate public input on legislation, a new feature has been added to the Nebraska Legislature's website for submission of written statements on pending legislation on the Legislature's website at any stage of the process. To access this feature, visit the bill's page at https://nebraskalegislature.gov/bills/view_bill.php?
DocumentID=43739
and click the corresponding button near the top of the bill page.

These submissions will not be considered testimony or part of the public hearing record, but the submitted statements will be available on the UniNet for access by senators and staff throughout the session. Please note, there should be no expectation of privacy regarding comments submitted in this format. If a citizen uses the database to submit his or her views prior to the public hearing on a bill or resolution, this option will allow input to the members of the committee prior to any committee votes.

Economic forecasting board raises revenue projections October 28, 2022

The Nebraska Economic Forecasting Advisory Board voted to raise revenue projections for the current fiscal year during an Oct. 28 meeting at the Capitol. The board provides an advisory forecast of general fund receipts that is used by the Legislature to craft the state's budget.

The board's projections for fiscal year 2022-23 were raised based on anticipated increases in revenue receipts across all

categories, including projected increases of \$405 million in individual income tax and \$113 million in corporate income tax.

Total projected revenue receipts for FY2022-23 were raised to \$6.44 billion, an increase of \$621 million.

The board also set the forecast for projected total revenue receipts for FY2023-24 at \$6.47 billion, an increase of \$809.5 million. Projected total revenue receipts for FY2024-25 were set at \$6.55 billion, an increase of \$1.05 billion.



<u>Starting Jan. 1, TRICARE Beneficiaries Must Reconfirm Mail Order Refills</u> <u>DECEMBER 19, 2022</u>

Beginning in January, Tricare will require patients using its mail-order pharmacy to confirm that they want their prescriptions refilled, rather than sending them automatically.

Express Scripts, Tricare's pharmacy benefits manager, began notifying patients the week of Dec. 5 of the pending change. According to the email, Tricare Mail Order Pharmacy users will receive a notification via email or text when their prescription is up for a refill and must log in to confirm the request.

WASHINGTON — Today, the Department of Veterans Affairs announced it will begin processing PACT Act benefits claims for eligible terminally ill Veterans.

While VA does not have the authorities or capabilities to begin fully processing PACT Act claims for all other Veterans until Jan. 1, 2023, VA was able to expedite processing for terminally ill Veterans to Dec. 12. This ensures terminally ill Veterans will receive their earned benefits and health care on the earliest possible date.

"These Veterans have stepped up to serve our country in the times when we needed them most — and now it's our job to step up for them," said VA Secretary Denis McDonough. "It's the right thing to do to get these heroes the world-class health care and benefits they've earned as soon as possible, and that's exactly what we're going to do."

Dec. 12 is the earliest date VA could begin processing claims for terminally ill Veterans. Until Jan. 1, 2023, VA will only finalize decisions on PACT Act claims that result in a grant of benefits for terminally ill Veterans. Claims that cannot be granted immediately will be held for further evaluation after publication of sub-regulatory guidance implementing the PACT Act.

When VA can begin processing all PACT claims Jan. 1, 2023, VA will continue to prioritize the processing of PACT Act claims for terminally ill Veterans. At that point, VA will also prioritize PACT Act claims filed by Veterans with cancer, Veterans experiencing homelessness, Veterans older than 85 years old, Veterans experiencing financial hardship and Medal of Honor and Purple Heart recipients.

Emotional numbing in PTSD is associated with lower reactivity to pain in the amygdala

A neuroimaging study on U.S. military veterans showed that the amygdala region of the brain of veterans with post-traumatic stress disorder (PTSD) showed lower reactivity to pain compared to the same region of the brain of veterans without PTSD.

Patterns were unique to this region of the brain and the researcher link this to emotional numbing, a restriction in the capacity of an individual to experience emotions. Other brain regions associated with processing pain were unaffected. The study was published in Neuropsychopharmacology.

PTSD is a disorder that sometimes develops in people who have experienced a traumatic event or a series of traumatic events. While most people will experience substantial stress reactions to such events, these reactions will sometimes persist over time and lead to this disorder.

The most well-known symptoms of PTSD include intrusive memories of the traumatic event, the so-called flashbacks, bad dreams and frightening thoughts, but symptoms also include higher pain tolerance, emotional numbing and many others.**MORE:**

Changes to TRICARE Expected in 2024

FALLS CHURCH, Va. – A new TRICARE contract that facilitates beneficiary health care in the civilian sector, known as T-5, is expected to start in 2024. The changes will improve the delivery, quality, and cost of health care services for services for service members, retirees, and their families.

There will continue to be two regional contractors. On December 22, 2022, the Defense Health Agency (DHA) announced that Humana Government Business and TriWest Healthcare Alliance Corporation will be the regional contractors, also known as managed care support contractors. If you live in the TRICARE East Region, Humana Government Business (Humana Military) will administer your health plan and provide TRICARE coverage. If you live in the TRICARE West Region, TriWest Healthcare Alliance Corporation will administer your health plan and provide TRICARE coverage.

"I am pleased that our new T-5 TRICARE contracts will continue to focus on enhancing the experience of care and great health care outcomes for our service members, retirees, and their families," said Lt Gen Ronald Place, Director, Defense Health Agency.

Governor's and Mayor's Challenges to Prevent Suicide Among Service

Members, Veterans, and their Families

SAMHSA has partnered with the United States Department of Veterans Affairs (VA) to bring the Governor's and Mayor's Challenges to Prevent Suicide Among Service Members, Veterans, and their Families (SMVF) to states, territories, and communities across the Nation. For the Governor's Challenge, 52 states and territories are taking part in the challenge and are working to develop and implement state-wide suicide prevention best practices for SMVF, using a public health approach. For the Mayor's Challenge, 22 communities were originally engaged as part of the challenge. Currently, 19 of those teams are still actively participating, and sixteen of the communities are within participating Governor's Challenge states. SAMHSA's SMVF TA Center is providing technical assistance for these initiatives.

Works with the National Mental Health and Substance Use Policy Laboratory to collect information from program grantees to evaluate and disseminate information on evidence-based practices, including culturally and linguistically appropriate services, as appropriate, and service delivery models

Improves access to reliable and valid information on evidence-based programs and practices, including information on the strength of evidence associated with such programs and practices, related to mental and substance use disorders Compiles, analyzes, and disseminates behavioral health information for statistical purposes

MISCELLANEOUS INFORMATION

Public Sector Veterans Preference

Nebraska Law requires that a preference shall be given to eligible veterans, service members, and eligible spouses seeking initial or return (unless terminated for disciplinary reasons) employment with the State of Nebraska or any state or local government.

Veterans with passing scores on all parts of an examination or numerical scoring shall have five percent added to their passing score if a claim for such preference is made on the application. An additional five percent shall be added to the passing score or numerical scoring of any disabled veteran. Such preference must also be given to the spouse of a service member during the time in which the service member serves on active duty and up to one hundred eighty days after the service member's discharge or separation from service.

All notices of positions of employment available for Veteran's Preference and all applications for such positions shall state that the position is subject to a Veteran's Preference. Veterans that applied and are not hired shall be notified by phone, mail or e-mail that they have not been hired and shall be advised of any administrative appeal available.

Private Sector Voluntary Veterans Preference

The Nebraska Legislature passed LB 272 in 2015, creating the Voluntary Veterans Preference Act. The Act provides private sector employers having a veteran's preference policy the opportunity to be listed on the Nebraska Dept. of Labor's Voluntary Veterans Preference Registry. Employers listed on the registry may implement veteran's preference policies without having to be concerned that hiring decisions may violate a state or local equal employment opportunity law.

Neb. Rev. Stat. §48-238 (5) states that "A voluntary veterans preference employment policy shall not be considered a violation of any state or local equal employment opportunity law including the Nebraska Fair Employment Practice Act."

Any private employer with a Voluntary Veterans Preference policy may register with the Nebraska Department of Labor by clicking on the link above. A registry of the employers and policies is available for review online.

B-21 Raider makes public debut; will become backbone of Air Force's

bomber fleet

PALMDALE, Calif. (AFNS) --

In a tangible display of the nation's resolve in meeting security threats, the U.S. Air Force, on Dec. 2, publicly unveiled the <u>B-21 Raider</u>, the first new, long-range strike bomber in a generation and an aircraft specifically designed to be the multifunctional backbone of the modernized bomber fleet.

While the B-21 isn't expected to be operational and introduced into service for several more years, the formal unveiling ceremony hosted by Northrop Grumman Corporation at its production facilities in California is a significant milestone in the Air Force's effort to modernize combat capabilities. The B-21 is designed to be a more capable and adaptable, state-of-the-art aircraft that will gradually replace aging B-1 Lancer and B-2 Spirit bombers now in service.

According to design requirements, the B-21 is a long-range, highly survivable stealth bomber capable of delivering a mix of conventional and nuclear munitions. The aircraft will play a major role in supporting national security objectives and assuring U.S. allies and partners across the globe. MORE:
