#### Summary of letter sent to:

**Honorable Senator von Gillern** 

The Nebraska Veterans Coalition would like to honor Nebraska veterans who have served honorably in the armed services. Several states have legislation establishing a Veterans Hall of Fame. The Nebraska Veterans Hall of Fame would recognize and honor those military veterans who have significantly contributed to the State of Nebraska through their work and lives during and after military service.

We're reaching out to you to ask you to introduce a legislative bill to establish the Nebraska Veterans Honor of

#### Summary of letter sent to:

Honorable Senator Holdcroft,

The Nebraska Veterans Coalition found that several states exempt state income tax for active military pay and that Nebraska does exempt 100% State Income Tax for the Nebraska National Guard (Statute 77-2716 (21) a). This statute must be amended as the exemption excludes the U.S. Reserve Forces living in Nebraska. The following are Nebraska State income tax exemptions that should be considered:

- Exempt from NE Income tax (amend Statute 77-2716 (21) a)Inactive duty military pay for National Guard and Reserve members, salary for customary annual training, weekend drills, and other inactive duty training and AGR members
- Introduce a bill that provides a 100% state income tax exemption for military residents serving on active duty and stationed in NE, regardless of the length of their tour.
- Resident NOT stationed in NE; all military income is not taxable and considered a nonresident for tax purposes.
- Exempt Nebraska income tax for all Active-Duty military pay included in Federal AGI, including pay on Title 10 or Title 32, Annual Training, and for Active Training or Schools,
- We are contacting you to request that you introduce a legislative bill to exempt specific military active duty Nebraska income tax.

#### Summary of letter sent to

Honorable Senator Sanders,

The Nebraska Veterans Coalition requests a bill to provide a stipend similar to several other states to Veteran Service Organizations whose honor guards support fallen veterans by offering Military Funeral Honors.. Nebraska does not have a statute in Nebraska law that provides a fund of this type. The veteran service organizations in Nebraska struggle to maintain membership, and it is hard to find volunteers to perform as honor guards at veteran funerals. These funds will be used to offset costs paid by qualifying organizations that provide honor guard burial details at the funerals of qualifying Nebraska Veterans.

We are contacting you to request that you introduce a legislative bill to provide a \$75.00 stipend to Veterans Service Organizations for Honor Guard services per funeral.

Annotated Committee Hearing Guidelines

As always, persons attending a public hearing in person will have an opportunity to present verbal testimony to the committee and be subject to questioning by the committee members. In-person testimony is generally limited to at least 3 minutes, although the chair of each committee has discretion to modify that time limit. Persons verbally testifying will be listed as a testifier on the committee statement as has been the practice, and have their position included within the official committee hearing record

New and experienced users of the legislature's bill page may find sorting amendments, motions, and bill activity confusing. The Legislature is introducing a simplified bill page alternative. This page will show the process of the legislative bill, akin to a delivery tracker, as well as adopted amendments and successful motions. Those that wish to see all bill activity, including filed and pending matters, should switch to the "detailed view".

New this session, every bill voted out of committee will have additional documentation displayed along with the committee statement. The first document will be a list of those who submitted comments for the public hearing record. These names will be listed based on the position they took on that particular piece of legislation. The second document is a list of non-testifiers who attended the public hearing. These individuals signed the "white or gold sheet" in the back of the room but did not testify before the committee. ## Nebraska Passes Universal Job Licensing Law

In a win for workers and their families, Nebraska Governor Jim Pillen signed legislation on March 5 that eases occupational licensing restrictions so Nebraskans can more easily get a job. The bill, LB16, requires licensing agencies to recognize job licenses from other states, which means someone who moves to Nebraska with a good standing occupational license no longer has to jump through <u>unnecessary state-specific hoops</u> just to work in the Cornhusker State. Modeled by the Goldwater Institute in Arizona, this policy, also called "<u>universal licensing recognition</u>," <u>streamlines</u> the licensing process so workers can get to work faster. Since Goldwater helped Arizona pass a similar law in 2019, more than <u>9,000 workers</u> have already been safely licensed through universal recognition.

# The Military Spouses Residency Relief Act

Moving from place to place requires a lot of effort and changes. Two laws make it easier for military spouses regarding their residency, voting and state taxes.

In 2009, the Military Spouses Residency Relief Act amended the <u>Servicemembers' Civil Relief Act</u>. MSRRA allows maintain the same state of legal residency as the service member provided the spouse had also lived in the state. A second amendment to the SCRA, called the Veterans Benefits and Transition Act of 2018, allows military spouses to claim their service member's state of legal residence as their own, if they choose to do so.

# Prepare for VA's secure sign-in changes In 2025, you'll need to start using a Login.gov or ID.me account to sign in. Learn how to create an account

Why this matters to you

In 2025, you'll have 2 secure sign-in account options (Login.gov and ID.me) for all VA websites and apps. We'll remove the My HealtheVet option after January 31, 2025, and the DS Logon option after September 30, 2025. You'll still be able to use your My HealtheVet health portal—you'll just need to sign in to it with a Login.gov or ID.me account.

#### What you can do

Create a Login.gov or ID.me account now

We encourage you to create a Login.gov or ID.me account now. If you already have one of these accounts but haven't yet used it, start now so you have time to get used to it before the change. With Login.gov or ID.me, you'll have access to all the same information and services you use today.

# Nebraska Income Tax for U.S. Servicemembers, Their Spouses, and Civilians Working with U.S. Forces Information Guide March 2023 8-364.pdf

Overview The federal Servicemembers Civil Relief Act (SCRA) provides that compensation received by a servicemember from his or her uniformed service can be taxed only by the state in which the servicemember has his or her legal residence. The place of residence at the time of entry into the service is presumed to be the state of legal residence or domicile, and remains so until legal residence in another state is established. The Veterans Benefits and Transition Act of 2018 (VBTA) added an election to allow the military servicemember spouse to claim the military servicemember's state of residency for tax purposes for any taxable year of the marriage beginning with tax year 2018. Nebraska recognizes the Internal Revenue Service (IRS) designations of "combat zones" and allows the same income exclusions, filing extensions, suspension of audits, collection activities, and notices for servicemembers outside the U.S. Also, Nebraska extends the same provisions to civilians working with the U.S. Forces in combat zones, as allowed to civilians for federal tax purposes. Military retirement benefits are excluded from Nebraska taxable income for tax years beginning on or after January 1, 2022. This guidance document is advisory in nature but is binding on the Nebraska Department of Revenue (DOR) until amended. A guidance document does not include internal procedural documents that only affect the internal operations of DOR and does not impose additional requirements or penalties on regulated parties or include confidential information or rules and regulations made in accordance with the Administrative Procedure Act. If you believe that this guidance document imposes additional requirements or penalties on regulated parties, you may request a review of

the document. This guidance document may change with updated information or added examples. DOR

recommends you do not print this document. Instead, sign up for the subscription service at revenue.nebraska.gov to get updates on your topics of interest ......

- Nebraska Income Taxes on Military Pay: Military pay earned by Nebraska resident Service members is subject to state income taxes.
- Nebraska State Income Taxes on Military Retired Pay: Military retired pay is exempt from Nebraska
  income tax. Thrift Savings Plan (TSP) does not withhold taxes for state or local income tax, but it is
  reported annually on IRS Form 1099-R. TSP distributions after retirement are not subject to state
  taxes; early distributions may incur higher taxes.
  - Nebraska Taxes on Military Disability Retirement Pay: Military Disability Retirement Pay
    received as a pension, annuity, or similar allowance for personal injury or sickness resulting
    from active service in the U.S. Armed Forces should not be included in taxable income. Some
    of the payments that are considered disability benefits include Disability compensation and
    pension payments for disabilities paid to Veterans or their families.
  - · Grants for homes designed for wheelchair living
  - Grants for motor vehicles for Veterans who lost their sight or the use of limbs or benefits under a dependent-care assistance program
- Nebraska State Taxes on U.S. Department of Veterans Affairs Disability Dependency and Indemnity Compensation (DIC): DIC is a tax-free monetary benefit paid to eligible survivors of U.S. Armed Forces Service members who died in the line of duty or eligible survivors of Veterans whose death resulted from a service-connected injury or disease.
- Military Survivor Benefit Plan (SBP)/Reserve Component Survivor Benefit Plan (RCSBP)/Retired Serviceman's Family Protection Plan (RSFPP) Nebraska State Tax Benefits: SBP, RCSBP and RSFPP annuities are not taxed in Nebraska.
- Combat Zones Exclusion and Filing Extensions for Nebraska Income Taxes for Deployed Service Members: Nebraska follows federal guidelines for tax filing extensions and does not tax income

- received by a Service member while serving in a designated combat zone, contingency operation, or in a qualified hazardous duty area.
- Nebraska Wartime Veteran and Surviving Spouse Homestead Property Tax Exemptions: The
  Nebraska Homestead Exemption Program offers a full or partial property tax exemption for eligible
  Veterans and Surviving spouses on their homestead and one acre of land. To qualify, the Veteran or
  Surviving spouse must own and occupy the homestead from January 1 through August 15 of the
  taxable year. Veterans must have received an honorable discharge and served during the following
  wartime periods:
  - World War II, December 7, 1941, through December 31, 1946
  - Korean War, June 25, 1950, through January 31, 1955
  - Vietnam War, February 28, 1961, through May 7, 1975 (in the Republic of Vietnam)
  - Vietnam War, August 5, 1964, through May 7, 1975
  - Lebanon, August 25, 1982, through February 26, 1984
  - Grenada, October 23, 1983, through November 23, 1983
  - Panama, December 20, 1989, through January 31, 1990
  - Persian Gulf War beginning August 2, 1990
  - Global War on Terror beginning September 14, 2001, until a date to be determined
- Non-Service-Connected Totally Disabled Veterans Partial exemption based on income limits: This
  exemption is available for Veterans with a non-service-connected total disability rating from the VA
  and is based on Household Income Limits. Household income determines the percentage of
  exemption the Veteran is eligible for.
  - Service-Connected Totally Disabled Veterans and Surviving Spouses 100% exempt: This
    exemption is available to Veterans receiving compensation for a 100% service-connected
    disability rating from the VA. The homestead is 100% exempt regardless of homestead value
    and income level. Veteran or Surviving spouse must meet the following requirements who is
    receiving compensation for a 100% service-connected disability.
    - Surviving spouse (who does not remarry until age 57) and was married to a Veteran who: Died due to a service-connected disability.
    - Died while on active duty and was service-connected
  - Died while on active duty during wartime
  - Veterans and Surviving Spouses Whose Home was Purchased or Modified with Funds from the VA 100% exempt. This exemption is available to a Veteran who is paraplegic or has multiple amputations whose home was substantially contributed to by the VA. This homestead is 100% exempt regardless of homestead value and income level. This exemption is also available to the survivor's spouse if they do not remarry until age 57. Applications are made through local county assessors. All forms must be filed after February 1 and before June 30 each year.
- Nebraska Disabled Veteran Motor Vehicle Tax Exemption: Nebraska offers the Nebraska Disabled Veteran Motor Vehicle Tax Exemption for one motor vehicle owned and used for personal transportation by a disabled or blind Veteran of the U.S. Armed Forces.

Dear Friend,

I've got good news - Nebraska's tax reforms are starting to pay off. The Tax Foundation's 2025 State Tax Competitiveness Index shows Nebraska has climbed from #30 to #24, reflecting the positive changes in our tax code, primarily from income tax cuts in 2023. While some of this improvement is due to new methodology in the rankings, much of it is directly attributable to Nebraska's hard work over the last two years to improve the state's tax competitiveness. Earlier this week, I sat down on the <u>latest episode of Nebrakskanomics</u> with Platte Senior Tax Advisor Michael Lucci to discuss this rise in the rankings.

As a whole, the Great Plains region continues to be a leader on the tax front. Wyoming and South Dakota remain the top two states in the nation, and lowa made a significant leap this year, climbing from #33 to #20, surpassing Nebraska along the way. While our rise is encouraging, it underscores the need to keep pace with our neighbors to remain competitive.

Nebraska's corporate income tax now ranks #20 nationally, and our individual income tax is #26. Our sales tax continues to be a competitive advantage at #13, and Nebraska's unemployment insurance tax is among the best in the country, ranking #3. However, as we all know, property taxes and the inheritance tax remain major challenges, ranking #45 nationally and holding back our overall competitiveness.

The 2023 income tax reforms are already driving improvements, with additional rate reductions scheduled in the coming years. Yet significant opportunities remain to enhance Nebraska's tax code without a steep revenue cost. Reducing the tangible personal property tax burden for businesses and ag producers and lowering property tax levies would address our state's low property tax ranking.

Eliminating Nebraska's inheritance tax is another reform that has had the attention of our team for several years. As one of five states that still imposes this outdated tax, we are discouraging people from staying and investing in our communities and unnecessarily hurting our farmers, ranchers, and small business owners. When forty-five other states do not have an inheritance tax, you can imagine the impact on these rankings.

Tax rankings are not just numbers—they represent the environment that businesses and families navigate every day. By building on the progress we've made and addressing areas like property taxes, taxes on machinery and equipment, and repealing our state's inheritance tax, Nebraska can ensure a future where everyone thrives.

It's important to remember when discussing tax rankings that this analysis represents a specific point in time, and while this year's index showed positive movement for Nebraska, other states are continuing to make improvements. The upcoming 2025 legislative session is an immense opportunity for Nebraska to make great strides and compete with our neighbors.

The latest State Tax Competitiveness Index is proof that reform is both possible and impactful. Protecting the gains we've made while continuing to address opportunities for improvement gives us a shot to stay in the game and do what's right for Nebraska taxpayers.

A County Veterans Service Office staff provides confidential counseling and assistance to Veterans and their families applying for Federal, State, and County Veterans programs and benefits. Federal Veterans Benefits include education, vocational rehabilitation, service-connected disability, non-service disability pension, healthcare, and burial benefits.

Nebraska Veterans programs include a tuition waiver, admittance to a Nebraska Veteran's home, and emergency financial assistance from the Nebraska Veterans Aid Fund. Eligibility for State financial assistance requires Honorable or General (Under Honorable Conditions) discharge from active duty. This requirement is not met by active duty for training only. (Specific residency and service dates are required for some State Benefits)

#### Compromise Defense Bill Would Give Junior Troops 14.5% Pay Raise in 2025

Junior enlisted service members will get a 14.5% <u>pay raise</u> next year under a compromise defense bill expected to pass Congress this month.

Under a deal reached by the House and Senate over the weekend, this year's National Defense Authorization Act, or NDAA, will allow all service members to receive a 4.5% pay bump next year. Additionally, troops in the ranks of E-1 through E-4 will get an extra 10% on top of that, for a total of 14.5% for the military's most junior troops......
